



GOLF CAR RULES & REGULATIONS



GOLF CAR RESTRICTIONS

To help ensure public safety, use of cars on certain streets is restricted. After 12:00 p.m. each day, cars are prohibited from operating in the following areas (see map):

- The entire length of Grandstand Avenue
- Main Street, between Hayes Avenue and Grandstand Avenue
- The entire length of Hayes Avenue
- Midway Drive, between Hayes Avenue and Grandstand Avenue

FAILURE TO ADHERE TO THE ROUTE RESTRICTIONS OUTLINED WILL RESULT IN YOUR GOLF CAR BEING CONFISCATED.



- Golf cars are the only acceptable means of transportation. Continuous running vehicles that start with a key – i.e.: Gators™, Mules, Rhinos, ATV's and other similar vehicles are PROHIBITED.
- There is a \$200 fee per permit required for each car operated.
- Must be 18 or older with a valid driver's license and proof of insurance to operate a golf car. Drivers are required to have a valid driver's license present.
- **NO** Golf Car may be operated on the fairgrounds without a valid permit issued from the Central Cash Office located in the Main Grandstand. Those without an official permit will be confiscated.
- **PERMITS SHOULD BE DISPLAYED PROMINENTLY ON THE FRONT OF YOUR GOLF CAR.**

THE STATE POLICE WILL MONITOR ALL GOLF CAR USE. ANYONE VIOLATING THESE RULES AND REGULATIONS GOVERNING GOLF CARS WILL HAVE THEIR CAR CONFISCATED AND MAY LOSE THEIR CAR PRIVILEGES ON THE FAIRGROUNDS.

Releases and Indemnification:

- The Applicant agrees to assume all risk of loss and to indemnify and hold the State, its officers, agents and employees, harmless from and against any and all liabilities, demands, claims, suits, losses, damages, causation of action, fines or judgments, including costs, attorneys' and witnesses' fees, and expenses incident thereto, for injuries to persons (including death) and for loss of, damage to, or destruction of property (including property of the State) resulting from the negligence or misconduct of Applicant, its employees, agents, or subcontractors in the performance of the permit.
- The Department assumes no liability for actions of Applicant and is unable to indemnify or hold Applicant harmless for claims based on this permit. Unless provided by law, Applicant is not eligible for indemnity under the State Employee Indemnification Act (5 ILCS 305/1 et seq.). Any liability for damages that the State might have is expressly limited by and subject to the provisions of the Illinois Court of Claims Act (705 ILCS 505/1) and to the availability of suitable appropriations.

Revocation: The Department may revoke the permit and/or golf car privilege without penalty at any time for a violation of the applicable requirements, rules and laws relating to the issuance of such permit and/or golf car privilege.
